Undocumented Americans

"A Dreamer is an undocumented immigrant who came to the United States as a child. Dreamers often have only known the U.S. as home and identify as Americans...The average DACA recipient arrived in the United States at age 7 and has lived here for more than 20 years. " (Benenson 2020)



- Have no current legal status and no criminal record (USCIS 2021)
