### **1890S**

# JIM CROW SOUTH AND CONTINUED VOTER SUPPRESSION

Despite the Fifteenth Amendment, many states enacted poll taxes and literacy tests, significantly decreasing Black turnout.



# 2013

#### SHELBY COUNTY V. HOLDER

The Supreme Court ruled that Section 4(b), which determines what states are subject to preclearance, is unconstitutional.



# 1869

#### **FIFTEENTH AMENDMENT**

The right to vote cannot be abridged due to race, color, or prior servitude.



### 1965

#### THE VOTING RIGHTS ACT

The act outlawed discriminatory voting practices and required particularly oppressive states to report all election changes to the Department of Justice, a process called preclearance.



#### 2021

#### BRNOVICH V. DNC

The Supreme Court ruled that
Arizona election laws--which had a
discriminatory impact on minority
voters--were not burdensome
enough to justify a Section 2 of the
Voting Rights Act violation.

# John Lewis Voting Rights Advancement

## **Act of 2021**

The Voting Rights Act is essential to maintaining minority voting rights.

The John Lewis Voting Rights Advancement Act of 2021 created a new coverage formula for Section 4(b) and strengthened Section 2.

It is currently stalled in the Senate.
