13. Name at least one thing that should be improved about this course:

Comments
The weekly assignment and course project descriptions were overwhelmingly wordy, to the point of irrelevance and distraction. This was something unique to me in my academic career, as I had never had such trouble reading and synthesizing an assignment description...ones the size of a small novel, at that! Much of these assignment instructions were not helpful nor particularly necessary, in my opinion. Instead, these incredibly lengthy descriptions just served as distractions to what was already a challenging course.
This is my best. course ever! I thoroughly enjoyed myself .
The amount of recorded lecture each week was too much. It made it hard to determine what the vital concepts for each topic were and I really struggled to see the central theme each week. I also thought that the lectures did not always do a good job of preparing me to work on the assignments each week.
In general, I found the instructions for assignments to be so lengthy that I tended to get lost in what the actual expectations were. I certainly understand the explanations and descriptions are beneficial, but it would have been helpful to have at least a small section that laid out in very simple terms the components of each assignment.
In addition, I found the course project to be more confusing than I imagine it was intended to be. Given that many students in this course are brand new to economics, it would have been helpful to have more clarity around exactly how to choose a topic that would have accessible data. Since we didn't cover data analysis until after the course project was begun, this proved to be quite a struggle – and not in ways that facilitated learning. Perhaps in the future, an assignment in the early weeks could cover selecting a topic and feedback could be provided on data sets – or even specific data sets could be suggested from which to brainstorm topics.
I think having two reviews of the draft instead of one before the end of the semester would be helpful.
I can't think of anything. This was one of my favorite courses for my program (MNSP).
The instructions for the weekly assignments were very lengthy, while they contained very useful information, it can be overwhelming just reading the assignment. I would suggest making the instructions more concise.
Many of the videos seemed out of date (from 2017/2018?). It could be nice if those were updated. It would be nice to provide interactive education modules if they existed. The class was a lot of theory and not a lot of numbers so it was sometimes very hard to conceptualize.
I appreciate that we cover SO much in this course – knowing that we're not gong to become an expert in one niche aspect of economics, but more to get our bearings and understand the breadth of the topic and how it can be used to understand economic policies broadly and give us the tools to dive deeper into specific topics ourselves... However, I think it would have been nice to spend a little more time on the final projects – maybe using another module homework session to work on it and/or to focus on graphic representations of data (like the last two assignments). While I do feel like I was given the tools to delve into this more in my own, I think trading one graphing of PPP or supply/demand curves for communication of visual graphic would have been appreciated (at least by me).
