
WHAT IS IT ANYWAY??

EDUCATION FUNDING+ STUDENT LOAN RELIEF

- Congress provided quick and robust funding to the nation with the Coronavirus Aid, Relief, and Economic Security (CARES) Act.
- Congress needs to pass more funding to continue this coverage
- Schools are cutting funds to arts/special education/athletics to fund PPE and other requirements to be safe in school during Covid.
- Urge Congress to include additional and specific funding in the next COVID response package.
 - OT in K-12 schooling
 - Early intervention in the community
 - Student loan relief
 - Congress should place federal student loans in automatic forbearance, lowering their interest rate to 0%, and considering those months as qualified payments for federal student loan repayment programs

2021 MEDICARE CUTS

- 2021 proposed Medicare Physician Fee Schedule rule, the Centers for Medicare & Medicaid Services (CMS) recommends significant payment reductions to more than three dozen health care professions, including occupational therapy.
- CMS is using the revenue from these cuts to offset an increase in payments for primary care physicians.
- As a part of these payment reductions, occupational therapy practitioners are facing up to a 9% cut to Medicare Part B reimbursement, despite ongoing advocacy with Congress, the Department of Health and Human Services, CMS, and the Office of Management and Budget by AOTA, the American Physical Therapy Association, and the American Speech-Language-Hearing Association, and multiple physician specialty groups throughout 2019 and 2020.
- If adopted in the final rule, the cuts will be effective January 1, 2021, at a time when providers and patients will still be feeling effects of the COVID-19 pandemic.
- These cuts are the result of a Medicare statutory requirement known as "budget neutrality" which requires that any increase in costs to the Medicare program must result in decreased spending elsewhere in the Medicare program.
