UMDI worked on five iterations of projects associated with this initiative, and numerous stakeholders, including the MA Department of Early Education and Care and the MA Department of Public Health. Key goals were to understand and examine community capacity to support child development in various Massachusetts communities, identify needs and gaps in care associated with the consumer population, and to identify key practices and conditions that will support sustainability. Study components included extensive and mixed-method community-based data collection (including focus groups, key informant interviews, and web-based surveys), data management and analysis, and a series of reports documenting findings.
- Massachusetts Department of Public Health (MDPH), Children and Youth with Special Healthcare Needs: Systems Integration Project (2014-2017). The Children and Youth with Special Healthcare Needs: Systems Integration Project (CYSHCN: SIP), a state initiative funded by the Health Resources and Services Administration Maternal and Child Health Bureau, is an effort to enhance the system of care for children and youth with special healthcare needs and their families through systems integration. The goal of this funding is to achieve a comprehensive, coordinated, and integrated state and community system of services via a three pronged approach: coordination of care, integrating systems, and the creation and use of a shared informational resource. UMDI is working with MDPH to assess the process of program implementation as well as related outcomes and aims. As of January 2016, planned study components include state document reviews, key informant interviews with project leaders, outcome data collection, management, and analysis, and reports documenting findings.

 Massachusetts Quality Rating and Improvement System (QRIS) rates the
 practices and physical environments of early education and care settings across
 the Commonwealth. The study's aim was to understand issues of participation
 and examine the experience of early education and care programs within the
 Massachusetts Department of Early Education and Care (EEC) QRIS system.
 Conducted phone interviews of family-based, center-based, and out-of-school
 time programs, qualitative analysis of interview data, and report writing.
- Massachusetts Cancer Policy Project (2011). Responsible for the design, management and implementation of evaluation of employer practices targeting cancer screening prevention among employees, as requested by the Massachusetts Department of Public Health.
